# Work Health and Safety Amendment (Fees) Regulation 2018

under the

Work Health and Safety Act 2011

## Explanatory note

The object of this Regulation is to amend the *Work Health and Safety Regulation 2017*:

- (a) to increase certain fees, including fees relating to licences, accreditation as an assessor and registration of items of plant, and
- (b) to provide for a lower fee for certain applications that are lodged and paid for online.

This Regulation is made under the *Work Health and Safety Act 2011*, including section 276 of, and Schedule 3 to, that Act (the general regulation-making powers).

### **1 Name of Regulation**

This Regulation is the *Work Health and Safety Amendment (Fees) Regulation 2018*.

### **2 Commencement**

This Regulation commences on 1 July 2018 and is required to be published on the NSW legislation website.
