### **1 Name of Order**

This Order is the *Subordinate Legislation (Postponement of Repeal) Order 2019*.

### **2 Commencement**

This Order commences on the day on which it is published on the NSW legislation website.

### **3 Postponement of repeal of certain statutory rules**

The repeal, by section 10 of the *Subordinate Legislation Act 1989*, of the statutory rules listed in Schedule 1 is postponed from 1 September 2019 to 1 September 2020.
