### **Explanatory note**

The object of this Regulation is to amend the *Coal Mine Subsidence Compensation Regulation 2017* to specify the contributions to the Coal Mine Subsidence Compensation Fund that the Chief Executive of Subsidence Advisory NSW may levy on proprietors of certain coal mines.

This Regulation is made under the *Coal Mine Subsidence Compensation Act 2017*, including sections 33 and 51 (the general regulation-making power).
