# Motor Dealers and Repairers Amendment (Miscellaneous) Regulation 2021

under the

Motor Dealers and Repairers Act 2013

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Motor Dealers and Repairers Act 2013*.

## Explanatory note

The objects of this Regulation are as follows—

- (a) to expand the class of repair work that is electrical accessory fitting work so that it no longer excludes work involving cutting, splicing or altering wiring harnesses,
- (b) to provide for alternative qualifications for individuals to be granted tradesperson's certificates for classes of repair work that are body maker and glazing work,
- (c) to make amendments consequent on the enactment of certain Commonwealth Acts.

This Regulation is made under the *Motor Dealers and Repairers Act 2013*, including sections 62 and 100 and section 186, the general regulation-making power.

## **Motor Dealers and Repairers Amendment (Miscellaneous) Regulation 2021**

### **1 Name of Regulation**

This Regulation is the *Motor Dealers and Repairers Amendment (Miscellaneous) Regulation 2021*.

### **2 Commencement**

- (1) This Regulation commences on the day on which it is published on the NSW legislation website, except as provided by subclause (2).
- (2) Schedule 1[1]–[5] commence on 1 November 2021.

## Schedule 1 Amendment of Motor Dealers and Repairers Regulation 2014

**[1] Clause 34 Classes of repair work**

Omit clause 34(1)(c1), as inserted by the *Motor Dealers and Repairers Amendment (Tradesperson's Certificates) Regulation 2020*. Insert instead—

- (c1) **electrical accessory fitting work**—being the work carried out by persons who install or remove electrical accessories in or from motor vehicles, but does not include work carried out on hybrid or electrically powered motor vehicles,

**[2] Clause 34(2)**

Omit the subclause, as inserted by the *Motor Dealers and Repairers Amendment (Tradesperson's Certificates) Regulation 2020*.

**[3] Clause 36 Required qualifications for tradesperson's certificate**

Omit clause 36(1)(b). Insert instead—

- (b) for a body maker—
  - (i) Certificate III in Automotive Manufacturing Technical Operations—Bus, Truck and Trailer, being part of the Automotive Manufacturing Training Package, or
  - (ii) Certificate III in Engineering—Fabrication Trade,

**[4] Clause 36(1)(c1)**

Omit “being part of”, as inserted by the *Motor Dealers and Repairers Amendment (Tradesperson's Certificates) Regulation 2020*.

Insert instead “including the repairing wiring harnesses and looms unit from”.

**[5] Clause 36(1)(c3)(iv)**

Insert at the end of clause 36(1)(c3)(iii), as inserted by the *Motor Dealers and Repairers Amendment (Tradesperson's Certificates) Regulation 2021*—

or

- (iv) Certificate III in Automotive Vehicle Body, including the vehicle glazing specialist elective units from the Automotive Industry Retail, Service and Repair Training Package,

**[6] Clause 52 General provisions concerning the recording of information**

Omit “compliance” from clause 52(1). Insert instead “identification”.

**[7] Clause 52(5)**

Omit the subclause. Insert instead—

- (5) In this clause—
  - built date**, in relation to a motor vehicle, means—
    - (a) the date entered as the “build date” for the vehicle on the RAV, or
    - (b) otherwise—the date that, combined with the word “Built” or the words “Built Date”, appears on an adhesive sticker or metal plate affixed to the vehicle or on a sheet metal component of the vehicle.

***identification plate date***, in relation to a motor vehicle, means the date that appears on an identification plate authorised to be placed on a vehicle, or taken to have been placed on a vehicle, under the *Motor Vehicle Standards Act 1989* of the Commonwealth as in force immediately before its repeal.

***RAV*** means the Register of Approved Vehicles kept under the *Road Vehicle Standards Act 2018* of the Commonwealth, section 14(1).
