### **1 Name of Order**

This Order is the *Administrative Arrangements (Administrative Changes—Ministers and Public Service Agencies) Order (No 4) 2021*.

### **2 Commencement**

- (1) This Order commences on the day on which it is published on the NSW legislation website, except as provided by subclause (2).
- (2) Clause 4 is taken to have commenced at 3:30pm on 6 October 2021.

### **3 Amendment of Administrative Arrangements (Administrative Changes—Public Service Agencies) Order 2019**

#### **Clause 5 Ministers to whom Public Service agencies responsible**

Insert “Minister for Regional New South Wales” above “Minister for Police and Emergency Services” wherever occurring in relation to the Department of Communities and Justice and Resilience NSW.

### **4 Amendment of Administrative Arrangements (Administrative Changes—Ministers and Public Service Agencies) Order (No 3) 2021**

#### **Clause 7 Construction of references to Deputy Premier, Minister for Regional New South Wales, Industry and Trade**

Omit clause 7(a) and (b). Insert instead—

- (a) the Minister for Regional New South Wales, if used in or in relation to—
  - (i) legislation administered by the Minister, or
  - (ii) the *Appropriation Act 2021*, section 11,
- (b) in other cases—
  - (i) if used in relation to the Minister’s trade or industry functions—the Minister for Trade and Industry, or
  - (ii) otherwise—the Deputy Premier.

### **5 Construction of references to Department of the Arts, Sport and Recreation**

- (1) In the *Mount Panorama Motor Racing Act 1989*, sections 8B, definition of *authorised person*, paragraph (b) and 10(4)(c), a reference to the Department of the Arts, Sport and Recreation is to be read as a reference to the Office of Sport.
- (2) In the *Mount Panorama Motor Racing Act 1989*, sections 8B, definition of *authorised person*, paragraph (b) and 12A(a), a reference to the Director-General of the Department of the Arts, Sport and Recreation is to be read as a reference to the Chief Executive of the Office of Sport.

- (3) In the *Mount Panorama Motor Racing Act 1989*, section 12A(b), a reference to the General Manager, Sport and Recreation, Department of the Arts, Sport and Recreation is to be read as a reference to the Chief Executive of the Office of Sport.
