Explanatory note

The objects of this Regulation are to-

- (a) require the patient's date of birth to be included on prescriptions for restricted substances and drugs of addiction, and
- (b) further provide for the information to be recorded in the monitored medicines database, and
- (c) make provision for the secure storage of propofol on hospital wards, and
- (d) reduce the minimum age at which a person may receive certain vaccines from a suitably qualified pharmacist from 16 years of age to 12 years of age.

1 Name of Regulation

This Regulation is the Poisons and Therapeutic Goods Amendment (Prescription Requirements) Regulation 2022.

2 Commencement

- (1) This Regulation commences on the day on which it is published on the NSW legislation website, except as provided by subsection (2).
- (2) Schedule 1.2 commences on 1 November 2022.

Schedule 1 Amendment of Poisons and Therapeutic Goods Regulation 2008

1.1 Amendments commencing on publication

- [1] Clause 30 Storage of prescribed restricted substances in hospital wards Insert "or propofol" after "drugs of addiction" in clause 30(1).
- [2] Clause 30(3)

Omit the subclause.

[3] Clause 48A Supply by pharmacists of certain vaccines

Omit clause 48A(1A)(d). Insert instead—

- (d) a SARS-CoV-2 (COVID-19) vaccine,
- (e) human papillomavirus vaccine,
- (f) meningococcal vaccine.

[4] Clause 48A(1B) and (1C)

Omit the subclauses.

[5] Clause 48A(1AA)(a)

Omit "16 years of age". Insert instead "12 years of age".

[6] Clause 58 Administration by persons employed at hospitals and managed correctional centres

Omit clause 58(2). Insert instead—

- (2) A direction must be—
 - (a) written and given in person, or
 - (b) given in another manner approved by the Secretary.

[7] Clause 75 Storage in hospital wards

Insert "or propofol" after "prescribed restricted substances" in clause 75(1).

[8] Clause 120 Administration by persons employed at hospitals and managed correctional centres

Omit clause 120(2). Insert instead—

- (2) A direction must be—
 - (a) written and given in person, or
 - (b) given in another manner approved by the Secretary.

[9] Clause 174D Recording of information by prescribers

Omit clause 174D(2)(e). Insert instead-

- (e) healthcare identifier,
- (f) other relevant information approved by the Secretary.

[10] Clause 174D(3)(b)(iii)–(v)

Omit clause 174D(3)(b)(iii). Insert instead—

- (iii) the healthcare identifier for the practice if available,
- (iv) practice name and address,

[11] Clause 174E Recording of information by pharmacists

Omit clause 174E(2)(a)(v). Insert instead—

- (v) healthcare identifier,
- (vi) other relevant information approved by the Secretary,

[12] Clause 174E(2)(b)(iii)

Omit "if available,".

[13] Clause 174E(2)(b1)

Insert after clause 174E(2)(b)—

- (b1) the following information about the business from which the monitored medicine was supplied—
 - (i) healthcare identifier,
 - (ii) business name and address,
 - (iii) other relevant information approved by the Secretary,

[14] Clause 174E(2)(c)(ii)

Omit the subparagraph.

1.2 Amendments commencing on 1 November 2022

[1] Clause 35 Form of prescription

Insert ", date of birth" after "name" wherever occurring in clause 35(1)(b)(i) and (1A)(b).

[2] Clause 39 Prescriptions may be filled only if in proper form

Insert after clause 39(2)(a)—

(a1) the prescription fails to specify the patient's date of birth, or

[3] Clause 39(2A)

Omit the subclause. Insert instead-

- (2A) This clause does not prevent a pharmacist from supplying a substance on a medication chart prescription that otherwise complies with clause 35(1A) merely because—
 - (a) the prescription fails to specify the maximum number of times the substance may be supplied, or
 - (b) the prescription fails to specify the patient's date of birth.

[4] Clause 80 Form of prescription

Insert ", date of birth" before "and address of the patient" in clause 80(1)(b).

[5] Clause 85 Pharmacists may supply drugs of addiction on prescription

Insert at the end of clause 85(2)(b)—

, or

(c) the prescription fails to specify the patient's date of birth.

[6] Clause 174E Recording of information by pharmacists

Insert after clause 174E(1)—

- (1A) A pharmacist who supplies a monitored medicine must, for the purposes of the database, record the following information about the person who is supplied the medicine—
 - (a) full name,
 - (b) date of birth,
 - (c) street address.

[7] Clause 174E(2)(a)(i)–(v)

Omit the subparagraphs. Insert instead—

- (i) gender,
- (ii) healthcare identifier,
- (iii) other relevant information approved by the Secretary,
