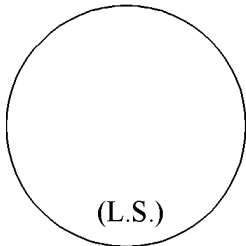

Explanatory note

The object of this Proclamation is to declare that the *Water Management Act 2000*, Chapter 3, Part 2, which provides for water management by access licences, applies to certain water sources and certain categories and subcategories of access licences relating to those water sources.

1 Name of Proclamation

This Proclamation is the *Water Management (Application of Act to Certain Water Sources) Proclamation 2022*.

2 Commencement

This Proclamation commences on the day on which it is published on the NSW legislation website.

3 Definition

In this Proclamation—

the Act means the *Water Management Act 2000*.

Note— The Act and the *Interpretation Act 1987* contain definitions and other provisions that affect the interpretation and application of this Proclamation.

4 Application of Act, Chapter 3, Part 2 to certain water sources and access licences

It is declared that the Act, Chapter 3, Part 2 applies to the following—

- (a) the water sources to which the following water sharing plans apply—
 - (i) *Water Sharing Plan for the Barwon-Darling Unregulated River Water Source 2012*,
 - (ii) *Water Sharing Plan for the Gwydir Regulated River Water Source 2016*,
 - (iii) *Water Sharing Plan for the Gwydir Unregulated River Water Sources 2012*,
 - (iv) *Water Sharing Plan for the Macquarie and Cudgegong Regulated Rivers Water Source 2016*,
 - (v) *Water Sharing Plan for the Macquarie Bogan Unregulated Rivers Water Sources 2012*,
 - (vi) *Water Sharing Plan for the Namoi and Peel Unregulated Rivers Water Sources 2012*,
 - (vii) *Water Sharing Plan for the NSW Border Rivers Regulated River Water Source 2021*,
 - (viii) *Water Sharing Plan for the NSW Border Rivers Unregulated River Water Sources 2012*,
 - (ix) *Water Sharing Plan for the Upper Namoi and Lower Namoi Regulated River Water Sources 2016*,
- (b) the following categories of access licences and its subcategories relating to the water sources mentioned in paragraph (a)—
 - (i) floodplain harvesting (regulated river) access licences,

- (ii) floodplain harvesting (unregulated river) access licences.
