Explanatory note

The object of this Regulation is to make minor amendments to the following regulations consequent on changes to the *National Construction Code* and the publication of an associated addendum to *Planning for Bush Fire Protection*, prepared by the NSW Rural Fire Service in cooperation with the Department of Planning and Environment—

1 Name of Regulation

This Regulation is the *Planning Legislation Amendment (National Construction Code) Regulation 2023.*

2 Commencement

This Regulation commences on 1 May 2023.

Omit "Table A1.7 of *Planning for Bush Fire Protection*ISBN 978 0 646 99126 9, dated November 2019" wherever occurring in the definitions of **bush fire attack level-40** (BAL-40) and flame zone (BAL-FZ).

Insert instead "Planning for Bush Fire Protection, Table A1.7".

[8] Section 271

Omit the section. Insert instead-

271 Planning for Bush Fire Protection—the Act, s 4.14(1)(a)

Planning for Bush Fire Protection, prepared by the NSW Rural Fire Service in co-operation with the Department, dated November 2019, as amended by the addendum published in November 2022, is prescribed.

[9] Section 272 Development excluded from bush fire prone land requirements—the Act, s 4.14(1C)

Omit "*Planning for Bush Fire Protection*ISBN 978 0 646 99126 9, dated 9 November 2019" from section 272(6).

Insert instead "Planning for Bush Fire Protection".

[10] Dictionary

Omit the definition of *Category 1 fire safety provision*, paragraphs (a) and (b).

Insert instead-

Part Provisions consequent on Planning Legislation Amendment (National Construction Code) Regulation 2023

Compliance with Building Code of Australia

- (1) A development application lodged before 1 May 2023 must be determined as if the *Planning Legislation Amendment (National Construction Code) Regulation 2023*, Schedule 1.3[1]–[7] and [9]–[11] had not commenced.
- (2) An application for a complying development certificate lodged before 1 May 2023 must be determined as if the *Planning Legislation Amendment (National Construction Code) Regulation 2023* had not commenced.
- (3) For an application specified in subsection (1) or (2), a reference to the *Building Code of Australia* in this Regulation is a reference to the version of the Code as in force when the application was lodged.

1.4 Environmental Planning and Assessment (Development Certification and Fire Safety) Regulation 2021

[1] Section 18 Requirement for performance solution report

Omit "A2.2(4) of the *Building Code of Australia*" from section 18(1)(b)(i). Insert instead "the *Building Code of Australia*, A2G2(4)".

[2] Section 18(3), definition of "prescribed report"

Omit "EP1.4, EP2.1, EP2.2, DP4 or DP5 in Volume 1 of the *Building Code of Australia*". Insert instead "the *Building Code of Australia*, Volume 1, E1P4, E2P1, E2P2, D1P4 or D1P5".

[3] Section 26 Building work to which Division applies

Omit "CP2 in Volume 1 of the *Building Code of Australia*" from section 26(2)(a) and (3)(a) wherever occurring.

Insert instead "the Building Code of Australia, Volume 1, C1P2".

[4] Section 26(2)(b) and (3)(b)

Omit "the verification method CV3 in Volume 1 of the *Building Code of Australia*" wherever occurring.

Insert instead "the verification method C1V3 in the Building Code of Australia, Volume 1".

[5] Section 26(4)

Omit "A5.2 of the *Building Code of Australia*" from section 64(5), definition of *required information*, paragraph (h).

[9] Schedule 1A Savings, transitional and other provisions

Insert at the end of the Schedule, with appropriate Part and section numbering-

Part Provisions consequent on commencement of Planning Legislation Amendment (National Construction Code) Regulation 2023

Compliance with Building Code of Australia—general

- (1) The following applications, lodged before 1 May 2023, must be determined as if the *Planning Legislation Amendment (National Construction Code) Regulation 2023* had not commenced—
 - (a) a development application,
 - (b) an application for a construction certificate,
 - (c) an application for a complying development certificate.
- (2) For an application specified in subsection (1), a reference to the *Building Code* of *Australia* in this Regulation is a reference to the Code as in force when the application was lodged.

Compliance with Building Code of Australia—certain applications lodged on or after 1 May 2023

- (1) This section applies to an application for a construction certificate—
 - (a) lodged on or after 1 May 2023, and
 - (b) relating to a building to which section 19(1A)(b) applies, and
 - (c) for which the application for the construction certificate specified in section 19(1A)(b) was lodged before 1 May 2023.
- (2) In determining an application to which this section applies—
 - (a) a reference to the *Building Code of Australia* in this Regulation is a reference to the Code as in force immediately before 1 May 2023, and
 - (b) section 26(5), as in force immediately before 1 May 2023, continues to apply to the application.
- (3) Section 26(5), as amended by the *Planning Legislation Amendment (National Construction Code) Regulation 2023*, does not apply to an application to which this section applies.
- (4) Subsections (2)(b) and (3) are repealed at the beginning of 1 August 2023.

[1] Section 4 Interpretation

Insert in alphabetical order in section 4(1)—

ABCB Housing Provisions Standard means the Housing Provisions Standard published by the Australian Building Codes Board from time to time.

[2] Sections 47(2) and 91(2)

Omit "the *Building Code of Australia*, Volume Two, section 3.7.1 and 3.8.6" wherever occurring.

Insert instead "the ABCB Housing Provisions Standard, Parts 9.3 and 10.7".

[3] Sections 48(4)(a) and (b) and 139(4)(a) and (b)

Omit "the *Building Code of Australia*, Volume Two, section 3" wherever occurring. Insert instead "the *ABCB Housing Provisions Standard*, Part 9.2".

[4] Sections 64(1) and 155(1)

Omit "the *Building Code of Australia*, Volume Two, Part 3.7.2" wherever occurring. Insert instead "the *ABCB Housing Provisions Standard*, Part 9.5".

1.6 Plantations and Reafforestation (Code) Regulation 2001

Appendix Plantations and Reafforestation Code

Omit section 25A(6), definition of *Planning for Bush Fire Protection*. Insert instead— *Planning for Bush Fire Protection* means the document prescribed by the *Environmental Planning and Assessment Regulation 2021*, section 271.

1.7 Plumbing and Drainage Regulation 2017

Clause 10 Additional requirements for proposed performance solutions
