Explanatory note

The object of this regulation is to declare the route for the Parramatta Light Rail Stage 2 Enabling Works. This regulation is made under the *Transport Administration Act 1988*, including sections 104N(2) and 119, the general regulation-making power.

1 Name of regulation

This regulation is the *Transport Administration (General) Amendment (Parramatta Light Rail) Regulation 2024*.

2 Commencement

This regulation commences on the day on which it is published on the NSW legislation website.

Schedule 1 Amendment of Transport Administration (General) Regulation 2018

[1] **Clause 15A, heading**

Insert “Stage 1” after “Rail”.

[2] **Clause 15A**

Omit “the Gazette on or before the commencement of this clause” from clause 15A(3).

Insert instead “Gazette No 134 of 7 December 2018”.

[3] **Clause 15AA**

Insert after clause 15A—

15AA Declaration of Parramatta Light Rail Stage 2 Enabling Works

- (1) For the Act, section 104N(2), the route from Melrose Park to Wentworth Point, as shown edged heavy black on the Parramatta Light Rail Stage 2 Enabling Works Map, passing along or through the roads, road-related areas and other land shown on the map, is declared to be the route of a light rail system.

Note 1— The route passes along or through Waratah Street, Mary Street, Wharf Road, the Ermington Boat Ramp then on a new bridge over Parramatta River, through part of the land at Lot 3, DP 271278, 14–16 Hill Road and along or through Hill Road and Footbridge Boulevard.

Note 2— The route includes tie-in areas at Waratah Street, Mary Street, Wharf Road, Footbridge Boulevard and Hill Road.

Note 3— The route passes through Archer Park in Melrose Park, a proposed foreshore park in Wentworth Point and Millennium Parklands including Woo-la-ra in Sydney Olympic Park.

- (2) The route of the light rail system includes the following—
- (a) the full width of the roads the route follows,
 - (b) the stratum above and below the surface area of land as shown on the map,
 - (c) the area of any bridge, viaduct or other support over which the route passes.
- (3) In this clause—
- Parramatta Light Rail Stage 2 Enabling Works Map*** means the map of the route of the Parramatta Light Rail Stage 2 Enabling Works approved by the Governor on the making of the *Transport Administration (General) Amendment (Parramatta Light Rail) Regulation 2024* and published in the Gazette.
