# Electoral Funding (Adjustable Amounts) (Electoral Expenditure) Notice (No 2) 2024

under the

Electoral Funding Act 2018

## 1 Name of Notice

This Notice is the *Electoral Funding (Adjustable Amounts) (Electoral Expenditure) Notice (No 2) 2024*.

## 2 Definition

In this Notice—

*the Act* means the *Electoral Funding Act 2018*.

## 3 Adjustment for inflation

For the purposes of clause 3(1) of Schedule 1 to the Act, the adjustable amounts that are to apply for the local government election period starting on 15 September 2024 and ending at the end of the election day of the successive local government general election are the amounts specified in Schedule 1 to this Notice.

## Schedule 1 Electoral expenditure caps

### 1 Adjustment--applicable caps on electoral expenditure for local government election campaigns: section 31 of the Act

(1) **Candidates and groups (other than groups including mayoral candidates): section 31(3) of the Act**

(a) **where the number of enrolled electors for the local government area or ward concerned for the election is 5,000 or fewer: section 31(3)(a) of the Act**

**Adjustable amount**

\$7,700

(b) **where the number of enrolled electors for the local government area or ward concerned for the election is more than 5,000 but fewer than 10,001: section 31(3)(b) of the Act**

**Adjustable amount**

\$12,800

(c) **where the number of enrolled electors for the local government area or ward concerned for the election is more than 10,000 but fewer than 20,001: section 31(3)(c) of the Act**

**Adjustable amount**

\$23,000

(d) **where the number of enrolled electors for the local government area or ward concerned for the election is more than 20,000 but fewer than 30,001: section 31(3)(d) of the Act**

**Adjustable amount**

\$31,900

(e) **where the number of enrolled electors for the local government area or ward concerned for the election is more than 30,000 but fewer than 50,001: section 31(3)(e) of the Act**

**Adjustable amount**

\$45,900

- (f) where the number of enrolled electors for the local government area or ward concerned for the election is more than 50,000 but fewer than 75,001: section 31(3)(f) of the Act
