The Early Childhood Education and Care Regulatory Authority directorate in the Department of Education is transferred to the NSW Early Learning Commission.

59 Construction of references to Secretary of Department of Education

A reference in the *Children (Education and Care Services National Law Application) Act 2010*, sections 9 and 10(2) to the Secretary of the Department of Education must be read as a reference to the person employed in the Public Service as the NSW Early Learning Commissioner.
