Appropriation (Parliament) Bill 2023

Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

This Bill is cognate with the *Appropriation Bill 2023*.

Overview of Bill

The object of this Bill is to appropriate from the Consolidated Fund a sum for the services of the Legislature for the 2023–24 financial year, including capital works and services, recurrent services and the repayment of debt.

Outline of provisions

Part 1 Preliminary

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act.

Clause 3 defines certain terms used in the proposed Act.

Part 2 Appropriation for Legislature

Clause 4 provides for the appropriation, out of the Consolidated Fund, to the Legislature for the services of the Legislature for the 2023–24 financial year.

Part 3 General

Clause 5 provides that certain payments made from the Consolidated Fund on or after 1 July 2023 pending the enactment of the proposed Act are deemed to be made out of the sums appropriated by the proposed Act.

This Act appropriates the sum of \$231,945,373 to the Legislature out of the Consolidated Fund for the services of the Legislature for the year 2023–24.

(b) capital expenditure to the sum of \$43,864,000.
