Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

Overview of Bill

The object of this Bill to permit digital evidence access orders to be sought in conjunction with search warrants issued under the *Independent Commission Against Corruption Act 1988*.

Outline of provisions

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act.

Clause 3 gives effect to the object set out in the overview.
