## Museums of History NSW Amendment (Chief Executive Officer) Bill 2024

### Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

#### Overview of Bill

The object of this Bill is to amend the *Museums of History NSW Act 2022* and the *Government Sector Employment Act 2013* to make the office of Chief Executive Officer of Museums of History NSW an office in the Public Service established by the *Government Sector Employment Act 2013*, rather than a statutory office established by the *Museums of History NSW Act 2022*.

### Outline of provisions

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on the date of assent to the proposed Act.

Schedules 1 and 2 give effect to the object set out in the overview.
