# Retail Trading Amendment (Anzac Day Trading Hours) Bill 2024

## Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

## Overview of Bill

The object of this Bill is to amend the *Retail Trading Act 2008* to restrict trading hours on Anzac Day.

## Outline of provisions

**Clause 1** sets out the name, also called the short title, of the proposed Act.

**Clause 2** provides for the commencement of the proposed Act.

## Schedule 1 Amendment of Retail Trading Act 2008 No 49

**Schedule 1[2]** provides that all shops, except for those identified in the *Retail Trading Act 2008*, Schedule 1, must be kept closed at all times on Anzac Day. **Schedule 1[1]** makes a consequential amendment to the definition of *restricted trading day*.

**Schedule 1[3]** provides that approval cannot be granted for a bank to be open on Anzac Day.
