This Act is the <i>Natural Resources Access Regulator Act 2017</i> .	4
<b>2 Commencement</b>	5
This Act commences on a day or days to be appointed by proclamation.	6

<b>Board</b> means the Board of the Regulator established under this Act.	9
<b>enforcement powers</b> , in relation to the natural resources management legislation, means any powers that may be exercised under that legislation in connection with the enforcement of that legislation, including:	10
(a) powers that may be exercised for the purposes of determining whether there has been compliance with or a contravention of that legislation, or	11
(b) the issuing of any notice, order or direction, or the imposition of any penalty or charge, under that legislation.	12
<b>function</b> includes a power, authority or duty, and <b>exercise</b> a function includes perform a duty.	13
<b>natural resources management legislation</b> means any of the following Acts and the regulations and other instruments made under those Acts:	14
(a) this Act,	15
(b) <i>Water Management Act 2000</i> ,	16
(c) <i>Water Act 1912</i> ,	17
(d) any other Act or part of an Act administered by a relevant Minister that is prescribed by the regulations.	18
<b>Regulator</b> means the Natural Resources Access Regulator constituted under this Act.	19

(1)	There is constituted by this Act a body corporate with the corporate name of the Natural Resources Access Regulator.	4 5
(2)	The Regulator is a NSW Government agency. <b>Note.</b> See section 13A of the <i>Interpretation Act 1987</i> in relation to the status, privileges and immunities of statutory bodies declared to be NSW Government agencies.	6 7 8
(3)	The Regulator is not subject to the control and direction of the Minister except to the extent specifically provided for under this or any other Act.	9 10
<b>5</b>	<b>Board of Regulator</b>	11
(1)	There is to be a Board of the Regulator.	12
(2)	The Board is to consist of 3 members appointed by the Minister.	13
(3)	The members of the Board are to be persons who together have experience and expertise in law, natural resources management, compliance and regulation and any other areas the Minister considers relevant.	14 15 16
(4)	The Board may establish committees to give advice and assistance to the Board in connection with any particular matter or function of the Board. It does not matter that some or all of the members of any committee are not members of the Board.	17 18 19

(1)	Any decision relating to the functions of the Regulator is to be made by or under the authority of the Board.	22 23

<b>7</b>	<b>General directions by Minister</b>	26
(1)	The Minister may give the Regulator a written direction with respect to the functions of the Regulator if the Minister is satisfied that it is necessary to do so in the public interest.	27 28 29
(2)	A direction by the Minister may be of a general nature only and may not relate to a specific matter that is being considered or determined by the Regulator.	30 31
(3)	In particular, a direction by the Minister under this section may not be made in relation to the following:	32 33

(3) The Chief Regulatory Officer is entitled to attend and to participate in discussions at meetings of the Board but is not entitled to vote at any such meeting.	8 9
<b>9 Staff of Regulator</b>	10
Persons may be employed in the Public Service to enable the Regulator to exercise its functions.	11 12
<b>Note.</b> Section 59 of the <i>Government Sector Employment Act 2013</i> provides that the persons so employed (or whose services the Regulator makes use of) may be referred to as officers or employees, or members of staff, of the Regulator. The principal objectives of the Regulator are:	19
(a) to ensure effective, efficient, transparent and accountable compliance and enforcement measures for the natural resources management legislation, and	20 21
(b) to maintain public confidence in the enforcement of the natural resources management legislation.	22 23
<b>11 Functions of Regulator</b>	24
(1) The Regulator has the following functions:	25
(a) to prepare strategies, policies and procedures relating to enforcement powers under the natural resources management legislation,	26 27
(b) to advise and report to the Minister or any relevant Minister on any matter relating to the administration of the natural resources management legislation,	28 29
(c) to provide the Minister or any relevant Minister with such other advice or reports as the Minister or relevant Minister may, by instrument in writing, request,	30 31 32
(d) to publish details of convictions in prosecutions for offences under the natural resources management legislation,	33 34
(e) such functions under the natural resources management legislation as are specified in Schedule 2,	35 36

## Schedule 2 Additional functions of Regulator

(Section 11 (1) (e))

### 1 Ministerial functions under Water Management Act 2000

The functions of the Minister administering the *Water Management Act 2000* under any of the following provisions of that Act:

- (a) section 60G (Minister may charge for water illegally taken),
- (b) section 78 (Suspension and cancellation of access licences),
- (c) section 78A (Notification of intention to suspend, cancel or require payment of penalty),
- (d) section 91I (Taking water when metering equipment not working),
