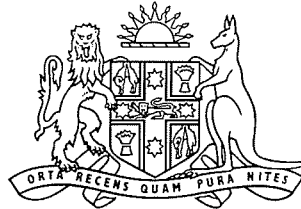

An Act to amend the *Crimes Act 1900*, the *Crimes (Domestic and Personal Violence) Act 2007* and the *Crimes (Sentencing Procedure) Act 1999* to make miscellaneous amendments in relation to domestic violence and sexual offences.

---

**The Legislature of New South Wales enacts—**

**1 Name of Act**

This Act is the *Crimes Legislation Amendment (Domestic Violence and Sexual Offences) Act 2025*.

**2 Commencement**

This Act commences on the date of assent to this Act.

**[1]      Section 66F Sexual offences—cognitive impairment**

Insert “or Director of Public Prosecutions” after “Attorney General” wherever occurring in section 66F(8).

**[2]      Section 78F**

Omit “Attorney-General” wherever occurring.

Insert instead “Attorney General or Director of Public Prosecutions”.

**Standard non-parole periods**

Part 4, Division 1A, Table, as in force immediately before its amendment by the *Crimes Legislation Amendment (Domestic Violence and Sexual Offences) Act 2025*, continues to apply in relation to the offence of murder committed before the amendment.
