(1) The Minister is, as soon as possible after 1 February 2017, to appoint an independent person to review this Act to determine whether the policy objectives of the <i>Retail Trading Amendment Act 2015</i> (the <b>amendment Act</b> ) remain valid and whether the terms of this Act remain appropriate for securing those objectives.	22 23 24 25 26
(2) The review is to be undertaken as soon as possible after 1 February 2017.	27
(3) A report on the outcome of the review is to be tabled in each House of Parliament on or before 1 September 2017.	28 29
