The provisions include requirements for the Commissioner for Fair Trading to keep a register of residential premises that contain, or have contained, loose-fill asbestos ceiling insulation and for owners of those premises to display warning signs at the premises. Currently, the provisions are limited to premises containing loose-fill amosite or crocidolite asbestos.
