An Act to constitute The Rector and Fellows of Saint John's College as a corporation; to repeal the *Saint John's College Act 1857*; and for other purposes.

<b>4</b>	<b>Constitution of The Rector and Fellows of Saint John's College</b>	2
(1)	There is constituted by this Act a corporation with the corporate name of "The Rector and Fellows of Saint John's College".	3 4
(2)	The College is a Roman Catholic residential college within the University and may also be known as the College of Saint John the Evangelist.	5 6
(3)	The College is a continuation of, and the same legal entity as, the corporation constituted by the former Act.	7 8
<b>5</b>	<b>Functions of College</b>	9
	The College has the following functions:	10
(a)	to provide accommodation, education and religious instruction to students,	11
(b)	any other functions conferred or imposed on it by or under this or any other Act.	12 13
	<b>Note.</b> See, for example, section 50 of the <i>Interpretation Act 1987</i> .	14
<b>6</b>	<b>Council of College</b>	15
(1)	There is to be a Council of the College.	16
(2)	The Council consists of the following members:	17
(a)	the Rector,	18
(b)	3 persons appointed by the Archbishop, each of whom must be a Roman Catholic priest or member of a Roman Catholic order,	19 20
(c)	4 lay persons elected under section 8,	21
(d)	1 lay person appointed by the Vice-Chancellor,	22
(e)	4 lay persons appointed by the Council.	23
(3)	The persons appointed as members by the Archbishop are <i>clerical members</i> .	24
(4)	The persons who are otherwise appointed or elected as members (other than the Rector) are <i>lay members</i> .	25 26
(5)	Each person appointed to the Council must have expertise and experience relevant to the Council's functions and an appreciation of the objects, values, functions and activities of the College.	27 28 29

(a)	to develop and implement policies and strategic plans for the administration of the College,	38 39
(b)	to develop and implement the College's educational and pastoral philosophy,	40
(c)	to manage the College's financial resources,	41

(d)	to oversee the performance of the College as a whole,	1
(e)	to monitor the performance of the Rector and the Vice-Rector,	2
(f)	any other functions conferred or imposed on it by or under this or any other Act or law.	3
(4)	The Council may, subject to any by-laws, establish committees to assist it in connection with the exercise of any of its functions.	5
<b>8</b>	<b>Election of lay persons to Council</b>	7
(1)	The election of 4 lay persons as members of the Council is to be held in accordance with any by-laws (or, if there are no by-laws relating to the election in force, in accordance with any procedures determined by the Council).	8
	<b>Note.</b> Clause 2 of Schedule 1 provides that 2 of the lay persons first elected to the Council will serve only 2 year terms, rather than the usual term of 4 years. As a result, an election will be held every 2 years to fill 2 vacancies.	10
(2)	The following persons only are eligible to vote in an election under this section:	11
(a)	a person who is a member or former member of the Council,	12
(b)	a person who was a member of the Council constituted under the former Act,	13
(c)	a person who is a graduate of the University and who has resided on the premises of the College for at least 1 academic year.	14
(3)	The Council is to maintain, in accordance with any by-laws, a roll containing the name and address of each person eligible to vote in an election under this section.	15

	In exercising the member's functions, a member must:	20
(a)	act in the best interests of the College as a whole, and	21
(b)	act honestly, in good faith and for a proper purpose, and	22
(c)	exercise a reasonable degree of care and diligence, and	23
(d)	not make improper use of the member's position to gain an advantage for the member or another person, and	24
(e)	disclose any interest (whether pecuniary or otherwise) that would conflict with the proper exercise of the member's functions and avoid exercising any function that could involve such a conflict of interest.	25

(1)	The Council may appoint a person as the Vice-Rector of the College.	17
(2)	A person appointed as Vice-Rector must be a Roman Catholic priest, a member of a Roman Catholic order or a practising Roman Catholic lay person.	18 19
(3)	The term of office and the terms and conditions of the appointment of the Vice-Rector are to be determined by the Council.	20 21
(4)	The Vice-Rector is to act in the office of Rector during the absence of the Rector, subject to any determinations of the Council. While so acting, the Vice-Rector has all the functions of the Rector and is taken to be the Rector.	22 23 24
(5)	The Vice-Rector also has any functions prescribed by the by-laws or determined by the Council.	25 26
<b>12</b>	<b>Council may suspend or remove Rector and Vice-Rector</b>	27
(1)	The Council may suspend or remove the Rector or the Vice-Rector from office for sufficient cause.	28 29
(2)	A person suspended or removed from office under this section may appeal to the Visitor for a review of the decision to suspend or remove the person from office.	30 31
(3)	The Visitor may affirm the decision to suspend or remove the person from office, vary the decision or set aside the decision and make a new decision in its place.	32 33
<b>13</b>	<b>Visitor</b>	34
(1)	The Archbishop is the <i>Visitor</i> of the College.	35
(2)	The Visitor has the functions conferred or imposed on the Visitor by or under this Act or any other Act or law.	36 37
<b>14</b>	<b>Chaplain</b>	38
(1)	If the person holding office as the Rector is not a Roman Catholic priest or member of a Roman Catholic order, the Archbishop may appoint a person, nominated by the Council, as the Chaplain of the College.	39 40 41

- (2) The Chaplain has the function of providing religious and spiritual support to students residing on the premises of the College.

(b)	the control and supervision of students residing on the premises of the College,	24

(d)	is removed from office by the Council in accordance with the by-laws, or	21
(e)	is absent from 3 consecutive meetings of the Council of which reasonable notice has been given to the member, except on leave granted by the Council or unless the member is excused by the Council for having been absent from those meetings, or	22
(f)	becomes bankrupt, applies to take the benefit of any law for the relief of bankrupt or insolvent debtors, compounds with his or her creditors or makes an assignment of his or her remuneration for their benefit, or	23
(g)	becomes a mentally incapacitated person, or	24

<b>5</b>	<b>Casual vacancy in office of elected member</b>	1
(1)	A casual vacancy in the office of a member elected under section 8 is to be filled:	2
(a)	by the candidate who received the highest number of votes in the most recent election other than the person elected, or	3
(b)	if there is no such person available to fill the vacancy, by a person appointed by the Council.	4
(2)	The person who fills the casual vacancy holds office, subject to this Act, for the remainder of the term of the member who has vacated office.	5
(3)	In this clause, <i>casual vacancy</i> means a vacancy that occurs other than because of the completion of a term of office.	6
<b>6</b>	<b>Extraordinary dismissal of Council</b>	7
(1)	This clause has effect despite any other provision of this Act.	8
(2)	If there are vacancies in the office of all 3 clerical members or in the office of 8 of the 9 lay members, the Visitor may, with the concurrence of the Vice-Chancellor:	9
(a)	remove the remaining members, and	10
(b)	appoint such persons as members as are necessary to enable the Council to be established in accordance with section 6.	11
(3)	A person removed under subclause (2) (a) may (but need not) be appointed as a member under subclause (2) (b).	12
(4)	A member appointed under this clause holds office, unless sooner removed from office, for a period of up to 3 years specified in the member's instrument of appointment.	13

(1)	The Council is to elect a Chairperson and a Deputy Chairperson from among the members.	19
(2)	The Rector may not hold the office of Chairperson or Deputy Chairperson.	20
(3)	The terms of office of the Chairperson and Deputy Chairperson are to be determined by the Council but must not exceed 3 years.	21
<b>8</b>	<b>Disclosure of material interests</b>	22
(1)	If:	23
(a)	a member has a material interest in a matter being considered or about to be considered at a meeting of the Council, and	24

- (b) the interest appears to raise a conflict with the proper performance of the member's duties in relation to the consideration of the matter, the member must, as soon as possible after the relevant facts have come to the member's knowledge, disclose the nature of the interest at a meeting of the Council.
- (2) After a member has disclosed the nature of an interest in any matter, the member must not, unless the Council otherwise determines:
- (a) be present during any deliberation of the Council with respect to the matter, or
- (b) take part in any decision of the Council with respect to the matter.
- (3) For the purpose of the making of a determination by the Council under subclause (2), a member who has a material interest in a matter to which the disclosure relates must not:
- (a) be present during any deliberation of the Council for the purpose of making the determination, or
- (b) take part in the making by the Council of the determination.
- (4) In this clause, *member* includes the Rector.

### **Part 3 Procedure**

#### **9 Procedure for Council meetings**

- (1) The procedure for the calling of meetings of the Council and for the conduct of business at those meetings is, subject to this Act and the by-laws, to be as determined by the Council.
- (2) The Chairperson (or, in the absence of the Chairperson, the Deputy Chairperson or, in the absence of both the Chairperson and the Deputy Chairperson, another member elected by the members of the Council who are present at a meeting) is to preside at a meeting of the Council.
- (3) The presiding member has a deliberative vote and, in the event of an equality of votes, also has a casting vote.
- (4) A decision supported by a majority of the votes cast at a meeting of the Council at which a quorum is present is the decision of the Council.

#### **10 Quorum**

- (1) The quorum for a meeting of the Council is 7 members.
- (2) In this clause, *member* includes the Rector.

#### **11 Transaction of Council business**

- (1) A meeting of the Council may be called or held using any technology consented to by all members.
- (2) The consent may be a standing one.
- (3) A member may only withdraw the member's consent a reasonable period before the meeting.
- (4) The Council may, if it thinks fit, transact any of its business by the circulation of papers among all the members of the Council for the time being, and a resolution in writing approved in writing by a majority of those members is taken to be a decision of the Council made at a meeting of the Council.
