Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

Overview of Bill

The object of this Bill is to amend the Road Transport Act 2013 to-

- (a) prohibit a person deliberately and recklessly driving through floodwaters, and
- (b) require penalties for breach of the prohibition to be paid into the New South Wales State Emergency Service Fund.

Outline of provisions

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on the date of assent to the proposed Act.
