3 Amalgamation of Western Lands leases: section 64A of the Act

- (1) Section 64A of the *Duties Act 1997* applies to the transfer of, or an agreement to transfer, a lease under the *Western Lands Act 1901*, being a lease for a purpose specified in an Order of the Governor made for the purposes of that section and published in the Gazette.
- (2) The following purposes are specified:
 - (a) grazing together with one or more of the following only:
 - (i) cultivation,
 - (ii) agriculture,
 - (iii) irrigation,
 - (iv) feedlot,
 - (v) film making,

(b)	cultivation together with one or more of the following only:
