State Environmental Planning Policy (Precincts—Central River City) 2021



Chapter 1 Preliminary

1.1 Name of Policy

This Policy is State Environmental Planning Policy (Precincts—Central River City) 2021.

1.2 Commencement

This Policy commences on 1 March 2022 and is required to be published on the NSW legislation website.

1.3 Definitions

In this Policy—

the Act means the Environmental Planning and Assessment Act 1979.

Note-

The Act and the *Interpretation Act 1987* contain definitions and other provisions that affect the interpretation and application of this Policy.

1.4 Transferred provisions

The *Interpretation Act 1987*, section 30A is taken to apply to the provisions transferred to this Policy on the commencement of this Policy in the same way as it applies to provisions transferred from a statutory rule to another statutory rule.

Note-

The Interpretation Act 1987, section 30A provides—

- (a) the transfer of a provision does not affect the operation or meaning of the provision, and
- (b) a transferred provision is to be construed as if it had not been transferred.

- (2) Renumber the clauses in Chapter 5 as sections with decimal numbering, commencing with section 5.1.
- (3) Insert as the heading of *State Environmental Planning Policy (Kurnell Peninsula)* 1989, Schedule 4—

(4) Transfer State Environmental Planning Policy (Kurnell Peninsula) 1989, Schedules 1–6, as amended by subsection (3), to this Policy as Schedules 9–14.

4 State Environmental Planning Policy (Urban Renewal) 2010

- (1) Transfer State Environmental Planning Policy (Urban Renewal) 2010, Parts 1 and 2, other than clauses 1 and 2, to this Policy as Chapter 6, Parts 6.1 and 6.2.
- (2) Renumber the clauses in Chapter 6 as sections with decimal numbering, commencing with section 6.1.

 - (b) provisions of a savings or transitional nature.
