Major Events Regulation 2017



New South Wales

Part 1 Preliminary

1 Name of Regulation

This Regulation is the *Major Events Regulation 2017*.

2 Commencement

This Regulation commences on the day on which it is published on the NSW legislation website.

3 Definitions

(1) In this Regulation—

the Act means the *Major Events Act 2009*.

Note—

The Act and the *Interpretation Act 1987* contain definitions and other provisions that affect the interpretation and application of this Regulation.

(2) (Repealed)

Part 2 2022 UCI Road World Championships

4 Part applies only in relation to 2022 UCI Road World Championships

The provisions of this Part relate only to the 2022 UCI Road World Championships and not to another major event.

5 References to the Act consequent on savings and transitional provisions—the Act, Sch 3, cl 1

In this Regulation, a reference to the Act is taken to be a reference to the *Major Events Act 2009* as if the *Major Events Amendment Act 2022* had not commenced except for the following provisions—

(a) Schedule 1[1], to the extent the amendment inserts the definitions of **authorised officer** and **promoter**,

- (b) Schedule 1[5],
- (c) Schedule 1[10],
- (d) Schedule 1[14],
- (e) Schedule 1[26],
- (f) Schedule 1[29],
- (g) Schedule 1[32],
- (h) Schedule 1[37].

6 Definition

In this Part—

2022 UCI Road World Championships means the 2022 Union Cycliste Internationale Road World Championships and associated events.

7 Declaration of 2022 UCI Road World Championships as major event

- (1) For the Act, section 5(1), the 2022 UCI Road World Championships is declared to be a major event.
- (2) For the Act, section 5(4)(a), the 2022 UCI Road World Championships comprises a road race and associated events taking place in the local government area of City of Wollongong during the major event period at a major event venue or facility.

Note—

The Act, section 4(2)(a) provides for a major event venue or facility to be declared by the Minister by order published in the Gazette.

8 Major event venues or facilities and major event periods—the Act, ss 4(2)(c) and 5(4)(b)

- (1) Each of the places listed in the tables to this clause are prescribed as a major event venue or facility.
- (2) A reference to the major event venues or facilities in this clause includes a reference to a public place, or part of a public place, that is within 200m of a major event venue or facility.
- (3) The major event period is the period from 17 September 2022 until 25 September 2022.
- (4) The periods listed in the table to this subclause are also major event periods for the corresponding major event venues or facilities to enable construction, management, removal and reinstatement of facilities.

8A Promoter—the Act, s 5(4)

For the Act, section 5(4)(d), Wollongong 2022 Limited (ACN 629 044 677) is prescribed.

9 Application of provisions of the Act, Part 4—the Act, s 5(4)(c)

- (1) Except as provided for by subclause (2), the Act, Part 4 applies during the major event periods.
- (2) Part 4, Divisions 1, 2 and 5–9 apply during the major event period specified in item 1 of the table to clause 8(4).

10 Responsible authority—the Act, s 6(a)

Destination NSW is designated as the responsible authority.

11 Sale and distribution of articles—sales control period

For the Act, section 37(9), definition of ***sales control period***, the period is 17 September 2022 to 25 September 2022.

12 Sale and distribution of articles—prescribed articles

- (1) For the Act, section 37(9), definition of ***prescribed article***, all articles are prescribed articles.
- (2) Subsection (1) does not apply to articles sold or distributed in the course of—
 - (a) a business that occupied premises on land at the time the land was prescribed to be part of the major event venue or facility for the major event period, and that are articles—
 - (i) normally sold or distributed in the course of the business, and
 - (ii) sold or distributed by the business in the usual manner, or
 - (b) a business, not established primarily for the purposes of the major event, that commences occupation of premises during the major event period on land prescribed to be part of the major event venue or facility for the major event period, and that are articles—
 - (i) normally sold or distributed in the course of businesses of that kind, and
 - (ii) sold or distributed in the usual manner in which businesses of that kind sell or distribute the articles.

13 (Repealed)

14 Advertising on buildings or structures—exemptions—the Act, s 39(11)(b)

- (1) Advertising material fixed to or placed on a building or structure in an area referred to in the Act, section 39(1)(b) is exempt from the Act, section 39 if—
 - (a) the advertising material is fixed to or placed on part of a major event venue or facility so that it cannot be clearly seen by a person, or
 - (b) the advertising material—
 - (i) was fixed to or placed on the building or structure when the building or structure was not an advertising controlled site or part of an advertising controlled site, and
 - (ii) was fixed or placed by a person as part of the person's ordinary activities and not in anticipation of the 2022 UCI Road World Championships, and
 - (iii) does not contain a statement, or make an inference, that the advertiser is a

sponsor or supporter of, or is connected with, the 2022 UCI Road World Championships.

Note—

The major event venue or facility must also be an advertising controlled site under the Act, section 39 for the exemption to have effect.

- (2) Advertising material fixed to or placed on a building or structure is exempt from the Act, section 39 if it is authorised or permitted to be fixed to or placed on the building or structure by the responsible authority in accordance with that section and this Part.

15 Aerial advertising

- (1) For the Act, section 40, a major event venue or facility prescribed in clause 8 or declared to be a major event venue or facility by the Minister under the Act, section 4(2)(a), is prescribed as a major event venue or facility.
- (2) The prescribed period is a period during which a sales control period is in effect under clause 11 for a major event venue or facility referred to in subclause (1).

16 Applications for authorisations

- (1) This clause applies to the following authorisations by the responsible authority—
 - (a) an approval under the Act, section 37 to sell or distribute a prescribed article during a sales control period in a controlled area,
 - (b) an authorisation or permission under the Act, section 39 for advertising material to be fixed to or placed on a building or structure that is, or is part of, an advertising controlled site,
 - (c) an authorisation under the Act, section 41 to do anything referred to in the Act, section 41(1) at a major event venue or facility.
- (2) A person who wishes to obtain an authorisation to which this clause applies must make an application to the responsible authority in accordance with this clause.
- (3) An application must—
 - (a) be made in writing, and
 - (b) be accompanied by the fee, if any, determined by the responsible authority (the **application fee**), and
 - (c) contain the information, and be accompanied by documentation, that the responsible authority requires to enable the responsible authority to properly consider and determine the application, and
 - (d) be lodged with the responsible authority at least 14 days, or a shorter period as

the responsible authority may allow, before the authorisation to which the application relates is proposed to be used.

- (4) The responsible authority may require an application for an authorisation to provide further information or documentation before the application is determined.
- (5) The responsible authority may waive or reduce an application fee.
- (6) The responsible authority may determine an application by granting the application, unconditionally or subject to conditions, or by refusing the application.

17 Modification of environmental planning instruments and development consents—expiry date

For the Act, section 51(7), definition of ***expiry date***, the date is 30 September 2022.

18 Parking control period—the Act, s 59(4)

The parking control period is the period from 1 September 2022 until 30 September 2022.

19 Delegation of responsible authority's functions—authorised person—the Act, s 68(3)(d)

The following are prescribed—

- (a) Wollongong City Council,
- (b) Wollongong 2022 Limited (ACN 629 044 677).
- (c) (Repealed)

20 Authorised officers—the Act, s 69A(2)

For the Act, section 69A(2)(c), the following classes of persons are prescribed—

- (a) persons engaged by the responsible authority to provide security services,
- (b) persons engaged by the responsible authority to provide traffic or pedestrian control services.

Part 3 ICC Men's T20 World Cup

21 Application of Part

This Part applies to the ICC Men's T20 World Cup only.

22 Interpretation

- (1) In this Part—

ICC Men's T20 World Cup means the International Cricket Council Men's T20 World Cup and associated events.

- (2) A reference in this Part to a named map is a reference to a map of that name approved by the Minister and published on the NSW legislation website.

23 Declaration of ICC Men's T20 World Cup as major event—the Act, s 5

- (1) For the Act, section 5(1), the ICC Men's T20 World Cup is declared to be a major event.
- (2) For the Act, section 5(4)(a), the ICC Men's T20 World Cup comprises a men's cricket tournament and associated events taking place in 2022 in Sydney during the major event period at the major event area.

Note—

The Act, section 4B provides for the major event area to be declared by the Minister by order published in the Gazette.

24 Major event periods—the Act, s 5(4)

For the Act, section 5(4)(b), the major event period for the major event is the following periods—

- (a) 22 October 2022,
- (b) 27 October 2022,
- (c) 29 October 2022,
- (d) 3 November 2022,
- (e) 5 November 2022,
- (f) 9 November 2022,
- (g) 10 November 2022.

25 Application of the Act, Part 4—the Act, s 5(4)

For the Act, section 5(4)(c), the following provisions of the Act, Part 4 apply in relation to the ICC Men's T20 World Cup for the whole of the major event period—

- (a) Division 1,
- (b) Division 2, other than section 17,
- (c) Division 4,
- (d) Division 5,
- (e) Division 9, other than sections 59 and 60.

26 Promoter—the Act, s 5(4)

For the Act, section 5(4)(d), T20 World Cup 2020 Ltd (ACN 618 113 269) is prescribed.

27 Responsible authority—the Act, s 6

For the Act, section 6(a), the Office of Sport is designated as the responsible authority.

28 Sale and distribution of articles—the Act, s 37

- (1) For the Act, section 37(1), the area prescribed as the controlled area is the area identified on the [ICC Men's T20 World Cup Controlled Area Map](#).

Note—

The [ICC Men's T20 World Cup Controlled Area Map](#) is published on the NSW legislation website in connection with this Regulation.

- (2) For the Act, section 37(9), definition of ***sales control period***, the period is the major event period.
- (3) For the Act, section 37(9), definition of ***prescribed article***, all articles are prescribed articles.
- (4) Subsection (3) does not apply to articles sold or distributed in the course of—
- (a) a business that occupied premises on land at the time the land was prescribed to be part of the major event area for the major event period, if the articles are—
 - (i) normally sold or distributed in the course of the business, and
 - (ii) sold or distributed by the business in the usual way, or
 - (b) a business, not established primarily for the purposes of the major event, that commences occupation of premises during the major event period on land prescribed to be part of the major event area for the major event period, if the articles are—
 - (i) normally sold or distributed in the course of businesses of that kind, and
 - (ii) sold or distributed in the usual way in which businesses of that kind sell or distribute the articles.

29 Advertising on buildings or structures—the Act, s 39

- (1) For the Act, section 39(1), the area prescribed as the advertising controlled site is the area identified on the [ICC Men's T20 World Cup Advertising Controlled Site Map](#).

Note—

The [ICC Men's T20 World Cup Advertising Controlled Site Map](#) is published on the NSW legislation website in connection with this Regulation.

- (2) Advertising material fixed to or placed in the advertising controlled site is exempt from the Act, section 39 if—
 - (a) the advertising material is fixed to or placed on part of a major event area so that it cannot be clearly seen by a person, or
 - (b) the advertising material—
 - (i) was fixed to or placed on the building or structure when the building or structure was not an advertising controlled site or part of an advertising controlled site, and
 - (ii) was fixed or placed by a person as part of the person's ordinary activities and not in anticipation of the ICC Men's T20 World Cup, and
 - (iii) does not contain a statement, or make an inference, that the advertiser is a sponsor or supporter of, or is connected with, the ICC Men's T20 World Cup.
- (3) Advertising material fixed to or placed on a building or structure is exempt from the Act, section 39 if it is authorised or permitted to be fixed to or placed on the building or structure by the responsible authority in accordance with that section and this Part.

30 Aerial advertising—the Act, s 40

For the Act, section 40(1), the airspace prescribed as the advertising controlled airspace is the airspace identified on the [ICC Men's T20 World Cup Advertising Controlled Airspace Map](#).

Note—

The [ICC Men's T20 World Cup Advertising Controlled Airspace Map](#) is published on the NSW legislation website in connection with this Regulation.

31 Applications for authorisations

- (1) This clause applies to the following authorisations by the responsible authority—
 - (a) an approval under the Act, section 37 to sell or distribute a prescribed article during a sales control period in a controlled area,
 - (b) an authorisation or permission under the Act, section 39 for advertising material to be fixed to or placed on a building or structure that is, or is part of, an advertising controlled site,
 - (c) an authorisation under the Act, section 41 to do anything referred to in the Act, section 41(1) within the major event area.
- (2) A person may apply to the responsible authority for an authorisation to which this clause applies.
- (3) An application must—

- (a) be made in writing, and
 - (b) be accompanied by the fee, if any, determined by the responsible authority (the **application fee**), and
 - (c) contain the information, and be accompanied by documentation, that the responsible authority requires to enable the responsible authority to properly consider and determine the application, and
 - (d) be lodged with the responsible authority at least 14 days, or a shorter period specified by the responsible authority, before the authorisation to which the application relates is proposed to be used.
- (4) The responsible authority may require an applicant to provide further information or documentation before the application is determined.
- (5) The responsible authority may waive or reduce an application fee.
- (6) The responsible authority may determine an application by—
- (a) granting the application, unconditionally or subject to conditions, or
 - (b) refusing the application.

32 Delegation of responsible authority's functions—the Act, s 68

For the Act, section 68(3)(d), T20 World Cup 2020 Ltd (ACN 618 113 269) is prescribed.

33 Authorised officers—the Act, s 69A(2)

For the Act, section 69A(2)(c), persons engaged by the responsible authority to provide security services are prescribed as a class of persons.

Part 4 FIFA Women's World Cup 2023

34 Application of part

This part applies to the FIFA Women's World Cup 2023 only.

35 Interpretation

- (1) In this part—

associated events includes training sessions, preparations in warm-up, competitions, the FIFA Fan Festival, official ceremonies, extension events, community events, participation events, media events, broadcast centre activities and other ancillary events.

FIFA Women's World Cup 2023 means the FIFA Women's World Cup 2023 and associated events.

- (2) A reference in this part to a named map is a reference to a map of that name approved by the Minister, held with Destination NSW and made available on the NSW legislation website.

36 Declaration of FIFA Women's World Cup 2023 as major event—the Act, s 5

- (1) For the Act, section 5(1), the FIFA Women's World Cup 2023 is declared to be a major event.
- (2) For the Act, section 5(4)(a), the FIFA Women's World Cup 2023 comprises a women's football tournament and associated events taking place in Sydney during the major event period at the major event area.

Note—

The Act, section 4B provides for the major event area to be declared by the Minister by order published in the Gazette.

37 Major event period—the Act, s 5(4)

For the Act, section 5(4)(b), the **major event period** is the period from 3 July 2023 until 27 August 2023.

38 Application of the Act, Part 4—the Act, s 5(4)

For the Act, section 5(4)(c), the following provisions of the Act, Part 4 apply in relation to the FIFA Women's World Cup 2023 for the whole of the major event period—

- (a) Division 2,
- (b) Division 3, other than sections 23, 24 and 25,
- (c) Divisions 4–9.

39 Promoter—the Act, s 5(4)

For the Act, section 5(4)(d), FWWC2023 Pty Ltd, ACN 650 853 302, is prescribed.

40 Responsible authority—the Act, s 6

For the Act, section 6(a), Destination NSW is designated.

41 Sale and distribution of articles in certain public places—the Act, s 37

- (1) For the Act, section 37(1), the area identified on the [FIFA Women's World Cup 2023 Advertising Controlled Area Map](#) is prescribed.
- (2) For the Act, section 37(9), definition of **prescribed article**, all articles are prescribed articles.
- (3) Subclause (2) does not apply to articles sold or distributed in the course of—

- (a) a business that occupied premises on land at the time the land was prescribed to be part of the controlled area, if the articles are—
 - (i) normally sold or distributed in the course of the business, and
 - (ii) sold or distributed by the business in the usual way, or
 - (b) a business, not established primarily for the purposes of the major event, that commences occupation of premises during the major event period on land prescribed to be part of the controlled area, if the articles are—
 - (i) normally sold or distributed in the course of businesses of that kind, and
 - (ii) sold or distributed in the usual way in which businesses of that kind sell or distribute the articles.
- (4) For the Act, section 37(9), definition of ***sales control period***, the period from 20 July 2023 until 20 August 2023 is prescribed.

42 Advertising on buildings or structures—the Act, s 39

- (1) For the Act, section 39(1), the area identified on the [FIFA Women's World Cup 2023 Advertising Controlled Site Map](#) is prescribed.
- (2) For the Act, section 39(11)(b), advertising material is exempted if—
 - (a) the advertising material is fixed to or placed on part of a building or structure in the advertising controlled site so that it cannot be clearly seen by a person, or
 - (b) the advertising material—
 - (i) was fixed to or placed on the building or structure when the building or structure was not an advertising controlled site or part of an advertising controlled site, and
 - (ii) was fixed or placed by a person as part of the person's ordinary activities and not in anticipation of the FIFA Women's World Cup 2023, and
 - (iii) does not contain a statement, or make an inference, that the advertiser is a sponsor or supporter of, or is connected with, the FIFA Women's World Cup 2023.

43 Aerial advertising—the Act, s 40

For the Act, section 40(1), the area identified on the [FIFA Women's World Cup 2023 Advertising Controlled Airspace Map](#) is prescribed.

44 Official title and official insignia—the Act, s 42

- (1) For the Act, section 42(3), definition of ***official insignia***, the logos, symbols and other

designs approved by the responsible authority and published in the Gazette on 3 May 2023 are prescribed.

- (2) For the Act, section 42(3), definition of **official title**, the title of the major event approved by the responsible authority and published in the Gazette on 3 May 2023 is prescribed.

- (b) security guards.

48 Applications for authorisations—the Act, ss 37, 39, 41 and 72

- (1) This clause applies to the following authorisations by the responsible authority—

- (a) an approval under the Act, section 37 to sell or distribute a prescribed article during a sales control period in a controlled area,
- (b) an authorisation or permission under the Act, section 39 for advertising material to be fixed to or placed on a building or structure that is, or is part of, an advertising controlled site,
- (c) an authorisation under the Act, section 41 to do anything referred to in the Act, section 41(1) at the major event area.

- (2) A person who wishes to obtain an authorisation to which this clause applies must make an application to the responsible authority in accordance with this clause.

- (3) An application must—

- (a) be made in writing, and
- (b) be accompanied by the **application fee**, if any, determined by the responsible authority, and

- (c) contain the information, and be accompanied by documentation, the responsible authority requires to enable the responsible authority to properly consider and determine the application, and
 - (d) be lodged with the responsible authority at least 14 days, or a shorter period, as the responsible authority may allow, before the authorisation to which the application relates is proposed to be used.
- (4) The responsible authority may require an application for an authorisation to provide further information or documentation before the application is determined.
- (5) The responsible authority may waive or reduce an application fee.
- (6) The responsible authority may determine an application by granting the application, unconditionally or subject to conditions, or by refusing the application.

49 Application of Schedule 1—the Act, s 73

- (1) For the Act, section 73(2), during the major event period—
- (a) each offence created by an applicable provision specified in Schedule 1 is an offence for which a penalty notice may be issued, and
 - (b) the amount payable for the penalty notice is the amount specified opposite the provision in the first column.
- (2) If the provision is qualified by words that restrict its operation to limited kinds of offences or to offences committed in limited circumstances, the penalty notice may be issued only for—
- (a) that limited kind of offence, or
 - (b) an offence committed in those limited circumstances.
- (3) In this clause—

applicable provision means a provision of the Act that applies in relation to the FIFA Women’s World Cup 2023 for the major event period under clause 38.
