An Act to amend the *Commission for Children and Young People Act 1998* to reduce the membership of the Parliamentary Joint Committee established under that Act.

### 1 Name of Act

This Act is the Commission for Children and Young People Amendment (Parliamentary Joint Committee) Act 2007.

#### 2 Commencement

This Act commences on the date of assent to this Act.

### 3 Amendment of Commission for Children and Young People Act 1998 No 146

The Commission for Children and Young People Act 1998 is amended as set out in Schedule 1.

### 4 Repeal of Act

- (1) This Act is repealed on the day following the day on which this Act commences.
- (2) The repeal of this Act does not, because of the operation of section 30 of the *Interpretation Act 1987*, affect any amendment made by this Act.

## [1] Section 29 Membership of Committee

Omit section 29 (1). Insert instead:

- (1) The Parliamentary Joint Committee is to consist of 7 members, of whom:
  - (a) 3 are to be members of, and appointed by, the Legislative Council, and

(b) 4 are to be members of, and appointed by, the Legislative Assembly.
