This Notice is the *Liquor (Adjustable Fee Amounts) Notice*.

2 Annual adjustment for inflation of periodic licence fees under **Liquor Regulation 2008**

For the purposes of clause 5D (6) of the *Liquor Regulation 2008*, the adjustable fee amount that is to apply for an assessment year specified in Column 1 of the Table to this clause in respect of the provision of that Regulation specified in Column 3 of that Table is the amount specified in Column 4 of that Table opposite that assessment year and provision.
