Long Service Leave Regulation 2016



New South Wales

1 Name of Regulation

This Regulation is the *Long Service Leave Regulation 2016*.

2 Commencement

This Regulation commences on 1 September 2016 and is required to be published on the NSW legislation website.

Note—

This Regulation replaces the *Long Service Leave Regulation 2011*, which is repealed on 1 September 2016 by section 10 (2) of the *Subordinate Legislation Act 1989*.

3 Definition

(1) In this Regulation, **the Act** means the *Long Service Leave Act 1955*.

Note—

The Act and the *Interpretation Act 1987* contain definitions and other provisions that affect the interpretation and application of this Regulation.

(2) Notes included in this Regulation do not form part of this Regulation.

4 Calculation of ordinary pay for payment of leave: bonuses

For the purposes of section 3 (2C) of the Act, the prescribed annual amount of a worker's ordinary pay is the greater of the following—

- (a) \$144,000,
- (b) the amount calculated in accordance with regulation 2.13 of Chapter 2 of the *Fair Work Regulations 2009* of the Commonwealth from time to time.

Note—

The Act provides that bonuses paid to workers are to form part of the ordinary pay of a worker for the purposes of payment for long service leave. Section 3 (2C) of the Act provides that bonuses received by a worker are not to be taken into account if the ordinary annual pay of the worker (excluding bonuses) exceeds the amount prescribed by the regulations. This clause prescribes that amount.

5 Savings

Any act, matter or thing that, immediately before the repeal of the *Long Service Leave Regulation 2011*, had effect under that Regulation continues to have effect under this Regulation.
