1 Name of plan

This plan may be cited as *Penrith Local Environmental Plan 1996—Classification of Public Land*.

2 Aims and objectives

This plan aims to change the classification under the *Local Government Act 1993* of the land to which this plan applies from community land to operational land.

3 Land to which plan applies

This plan applies to public land within the City of Penrith described in the Schedule.

4 Classification and reclassification of public land as operational

The public land described in the Schedule is classified or reclassified as operational land for the purposes of the *Local Government Act 1993*.
